2. Restructure of the FSC Office

A review was recently performed on all functions in the FSC Office and some realignment of roles and responsibilities has taken place. Here's a quick guide that will assist clubs in directing any enquiries:

David Ware (<u>davidware@footballsouthcoast.com</u>) will be responsible for the following:

- Junior's, Women's and Amateurs Competition Draws and registration enquiries and notification of any ground closures as a result of wet weather
- Management and co-ordination of all injuries and incidents reported across all football councils in accordance with the FSC Injuries and Incidents Management Policy
- Disciplinary Matters for Juniors (Suspension letters, team points administration and MRC co-ordination)
- GPT matters across ALL competitions (ie Men's Premiership, Women's, Amateurs, Juniors)
- Booking of all council grounds on behalf of FSC

David Naylor (davidnaylor@footballsouthcoast.com) will be responsible for the following:

- Men's Premiership Competition Draws, registration and team application enquiries, and events
- Disciplinary Matters for Senior Competitions (Suspension letters, team points administration and MRC co-ordination)
- Administration and assistance to the Referee Council and assistance with the appointment of referee's where required
- Media Liaison across all football councils

- Communications Manager Oversight of all Facebook and website content
- Procurement Manager
- Administration of all FSC youth programs including FSC Academy, Skills Acquisition,
 Regional Youth League and School Holiday Clinics
- FSC Events Management in conjunction with the relevant football councils
- Futsal Club Training bookings

In addition a new phone system has been implemented. This will allow callers to the FSC office to be directed to the relevant staff member based on the key functions identified above.

3. Review of the FSC Disciplinary Procedures

Following unification it was determined by the FSC Board that all disciplinary processes for Football competitions conducted under the auspices of Football South Coast (FSC) should be unified to the extent possible. For the 2013 season unified Disciplinary Regulations were developed and adopted by the Board.

Inherent in the Regulations is the responsibility to ensure regular review and this has recently occurred with discussions late last year and early this year with Stakeholders (various football council members) and participants (various MRC members, GPT members.).

Based on this review it was highlighted that these procedures were very successful in streamlining a fair and transparent disciplinary process. Some adjustments have been made to the processes most of which are tidying up issues. However, two substantial changes have been introduced:

- 1. The first enables action to be taken, following the submission of all reports called for on any incident. On review of those reports whereby the evidence appears consistent and straight forward, the Disciplinary Commissioner in consultation with the Chair of a Match Review Committee and the CEO (or delegate) can determine some draft sanctions from the tables of Offences to offer a Club for acceptance. The Club can accept these sanctions or choose to have the case heard by the appropriate Tribunal. The allowance of such action can save the time, cost and inconvenience associated with the calling of a Tribunal. It would be used sparingly and with considerable caution.
- 2. The second relates to the commitment and acceptance by the Men's Council for its Amateur competitions and the Women's Council to embracing the team points penalty system which has been used for some years by the Junior Council.

The system works on a cumulative deduction of points from a given number based on serious offences committed. A team can be impacted by the actions of its individual members in various ways as its cumulative deductions bring action against the team. The System builds a joint responsibility to ensure good behaviour – from the Club, officials and other players.
