B. Each team must nominate one player / official to undertake the relevant referee's course prior to season commencement and will be called upon to officiate games in the absence of an FSC appointed referee.

Where possible, this nominated referee will be required to officiate a game of another team sharing the same ground.

If the team already has an existing registered referee – they will not be required to undertake the relevant course.

- C. Each team / club must ensure that grounds are set up with line markings, nets, and flags prior to scheduled kick off times. Failure to do so may result in a \$50 fine.
- D. Each team / club must perform registration ID checks of the opposing team prior to kick off. Sign off on the team sheet will validate that this check has been performed by each team manager / coach.
- E. Each team / club accepts that FSC registered referee's officiating games will not be paid on the day via cash and that the team / club will be invoiced four (4) times during the year.

These referee's will be paid automatically into their nominated bank account.

Attachment A: Invoice Payment Policy

Football South Coast Invoice Payment Policy

Background

FSC regularly invoices clubs / teams for items such as player and team registration costs, referee payments, ground council hire fees, etc.

A number of these expenses such as ground hire and referee payments, are expenses of the clubs / teams that FSC pays and then invoices the clubs / teams for reimbursement of these costs.

The following policy outlines the conditions of payment of invoices that will apply from the 1st November 2014.

Conditions of Payment

- Upon issuance of the invoice, the amount payable is due within 30 days of the date of that invoice.
- Within the first 10 days of the month, the Treasurer and President receive a statement showing exactly what invoices are outstanding as at that date. This statement clearly shows the ageing amount of each invoice.
- If the amount on the invoice remains unpaid as at 60 days – the club will be charged at a rate of 1% per on the outstanding balance over 60 days to 90 days as at the end of each month
- If the amount on the invoice remains unpaid as at 90 days – the club will be charged at a rate of 2% per on the outstanding balance over 90 days as at the end of each month
- At the beginning of each month, Interest will be calculated monthly on the amount over 60 or 90 days and invoiced immediately to the club.

For example – if a club / team have an amount of \$1000 that is within the 60-90 day period and \$2000 over the 90 day period, as at the end of the month, interest will be calculated as follows:

- o \$1000 at 1%pa = \$10 to be invoiced for the month (for amounts 60-90 days outstanding)
- o \$2000 at 2%pa = \$40 to be invoiced for the month (for amounts over 90 days outstanding)
- o The club will therefore be invoiced \$50 for that month
- In addition to these interest charges clubs / teams may also incur additional penalties which may include suspension of all home games and a loss of competition points which will be at the discretion of the relevant football council and the FSC Board
- The FSC Board also has the discretion to alter these conditions for individual clubs / teams who will be notified in writing.
