Call for Nominations

Nominations of members of Brisbane Basketball Incorporated for the elections to the management committee are called for.

To be valid, nominations must:

- be of a current member of Brisbane Basketball Incorporated; and
- be in writing (a sample nomination form is Attachment 1 to this notice); and
- be signed by the candidate; and
- be signed by a member of Brisbane Basketball Incorporated who is proposing the candidate and by another member who is seconding the candidate; and
- be lodged with the Secretary with <u>resume</u> by close of business <u>2nd June 2016</u>.

LATE NOMINATIONS CANNOT BE ACCEPTED, UNLESS THERE ARE INSUFFICIENT NOMINATIONS IN WHICH CASE NOMINATIONS MAY BE TAKEN FROM THE FLOOR OF THE MEETING.

Members are not eligible to be nominated for election to the management committee if they:

- have been convicted on indictment of an offence for which the rehabilitation period (usually 5 or 10 years) has not expired; or
- have been summarily and sentenced to imprisonment (other than in default of payment of a fine) for an offence for which the rehabilitation period (usually 5 or 10 years) has not expired;
- are an undischarged bankrupt or subject to a form of insolvency administration outside Bankruptcy.

Voting at the AGM
