SCF are responsible for the management of all junior Futsal competitions conducted during the summer season across the south of Canberra. SCF manage our competitions under the FIFA laws of the game and through our by laws.

## **Registration Process**

All registrations are completed electronically. Individual players register through the *FFA My Football Club* website [www.myfootballclub.com.au](http://www.myfootballclub.com.au)

Please be sure you register for the South Canberra Futsal 2015-2016 summer season. Coaches and Managers also need to register as Volunteers with *My Football Club* for the competition.

The Team Registration Form is then completed by the Coach, including FFA numbers of all players, and emailed to [southcanberrafutsal@gmail.com](mailto:southcanberrafutsal@gmail.com)

All Teams must be registered by 18<sup>th</sup> September 2015. Late registrations after this will incur a \$5.00 late fee per player and will only be accepted to the competition if space exists.

**These are the steps to take for MFC registrations.**

- Step1** Log on to My Football Club
- Step2** Will come up with your current details. Click **Register Now**
- Step3** **Check details.** Scroll to bottom of page click **proceed with registration**
- Step4** Type in **South Canberra Futsal** for the club with which to register
- Step5** Select **"player"**
- Step6** Select **package**
- Step7** Click **"Add"**
- Step8** Scroll to bottom of page. **Accept terms**
- Step9** Pay through MFC to pay by credit card or Click **"invoice me"**

## **Coaches and Managers meeting**

## **Playing Strips**

- Representative uniforms (including socks) must not be worn at any time.
- No Team is permitted to wear Black Shirts
- Each team is to supply their own matching playing strips which include socks, shorts, and numbered shirts with sleeves. SCF does have some Strip sets for hire; contact the Administrator by phone during office hours or email.
- Numbers 1 – 15 are recommended, however there is no restriction on what numbers are used.
- All Goal Keepers must wear a shirt colour which distinctly contrasts with the other players' shirts and must have a number. Number 1 is recommended it is compulsory for players to wear shin pads, non-marking shoes and long socks that completely cover shin pads.

The [\*Working with Vulnerable People \(Background Checking\) Act 2011\*](#) (the Act) commenced on 8 November 2012 and aims to reduce the risk of harm or neglect to vulnerable people in the ACT. The introduction of a centralised background checking system in the ACT has benefits for vulnerable people, employees, volunteers, organisations and employers. The system establishes mandatory minimum checking standards that will apply across regulated activities.
